

# Minutes of meeting of SOPLEY PARISH COUNCIL held at Sopley Parish Hall on Monday, 17<sup>th</sup> April 2023 at 7.30pm

**Present:** Chairman D Shutler, Cllr Allen, Cllr Vines, Cllr Partridge, Cllr Dunn and Cllr McDonnell and Mrs K Hughes (Clerk) Cllr Michael Thierry joined the meeting at 8pm and 6 members of the public.

# The clerk confirmed that the meeting was quorate.

## 1. Parishioner participation.

- Two parishioners attended from Heatherstone Grange and requested a grant for a Coronation bench to be installed around a tree at on HG Village Green all Grant application documentation had been already supplied by email to the Clerk and Council Members. £1500 was requested. One of the gentlemen had knowledge of the Labouring Poor Allotment Account and asked could the funds to be made available from there. ACTION: Clerk to investigate the source of funding. Cllr Thierry agreed a donation of £500 from his available funds. A grant was agreed in principle by all Council members for £1000 upon further investigations of the classification of the tree. ACTION: Applicants to gain further clarification from NFDC and Open Spaces.
- A parishioner mentioned the "dirty" Welcome to Sopley signs and could they be cleaned. **ACTION: Clir Dunn agreed to sort them out and clean them.**
- Missing signs still not been replaced by highways outside the Post Office. **ACTION: Cllr Vines to raise enquiry.**
- Missing Sopley sign in Derritt Lane on entering Sopley Village. ACTION: Cllr Vines to raise enquiry.
- Can we get Highways maps of Derritt Lane so we can pinpoint ownership/responsibility. **ACTION:** The Clerk.
- Apologies were received from Mr Emmel and the Clerk was asked to see when there would be a permanent repair of the Woolpack Bridge pothole. **ACTION: Clerk/Cllr Vines.**
- **2. Apologies for absence**. Cllr Langford.
- 3. Declarations of Interest/Requests for Dispensation received by the Clerk. There were none.
- 4. PREVIOUS MINUTES: The Minutes of the Parish Council meeting held on 16th March 2023 were approved as a correct record and signed by the Chair. There were no matters arising from these minutes.

- **5. ACTION LIST UPDATE.** (Chairman Shutler ran through the Action List which had been circulated to all Council members).
  - Speedwatch is due to start but ideally more volunteers are needed. ACTION CIIr Vines to coordinate.
  - Overgrown hedgerows around the one-way system in Sopley Village. R&B Maintenance scheduled to start some works, but the Hedges opposite the Woolpack carpark need the Tree Management Company to assist. ACTION: Clerk to source quotes for this work.
  - Bulbs are to be planted in the Autumn on the triangle at the end of Priest Lane. **ACTION: Clerk/Clir Dunn.**
  - Refurbishment of the telephone box to be started once 3 quotes have been collated by the Clerk and then instruction to commence works will be given. **ACTION: Clerk/Clir McDonnell.**
  - Costrell's Yard no contact has been made by landowner or tenant, so the Clerk is to contact enforcement at NFDC for clarification of the land usage and residential status. **ACTION: Clerk.**

  purchased for the Coronation. ACTION: Clerk.
- Purchase of Speed indicator device £2339.99 plus VAT to be ordered by the Clerk and hand held radar gun £166.00 plus VAT as recommended by Hampshire Police and quotes have been sourced. This is to enable commencement of Speedwatch in Sopley Village. Cllr Vines to project manage. All SPC Council members authorised the purchase for this ongoing project and persistent speeding problem in the village. ACTION: Clerk/Cllr Vines.
- R&B Maintenance are starting hedge and path tidy up on 19<sup>th</sup> April 9am. Cllr Dunn to oversee this project. To be funded by Lengthsman scheme 2022-2023 left over funds approved by all Council members. ACTION: Cllr Dunn.
